O R D E R

We have perused and considered the report filed by the State Coordinator, NRC. We have heard learned Attorney General as well as the State Coordinator.

No specific difficulty in carrying out the work of NRC up-gradation has been brought to our notice to require any further orders. We, accordingly, direct the State Coordinator to continue with the work to meet the deadline already set by this Court for final publication of the NRC

i.e. 31st July, 2019, which, we have made clear, will not be extended under any circumstances.
