different compartments/phases with specific time Schedule for completion of each phase so that the work of updating of NRC is completed by December, 2016 if not earlier. The Nodal Officer will also indicate whether it is possible to complete the aforesaid work before December, 2016. The

Nodal Officer will also indicate the availability of funds at this stage for undertaking the exercise.

Having regard to fact that clarifications may be required in respect of what would be stated by the Nodal Officer in his affidavit in terms of the present order to expedite matter, we direct the Nodal Officer to be personally present in Court on 23rd September, 2014 at 2.00 p.m.
