Celebrate homecoming this Magh Bihu with NSK BASED SPECIAL VERIFICATION DRIVE

Dear all NRC applicants currently residing outside Assam, let us take the NRC opportunity to come home this Magh Bihu and relish the traditional feast and warmth of bonfire. Take a day off and visit your designated NRC Seva Kendra (NSK) to get your Forms verified.



We are launching “NSK Based Special Verification Drive”

Period : 1st – 18th January 2016 *excluding Sundays & Magh Bihu holidays on 15th & 16th January 2016

Venue : Your Designated NRC Seva Kendra (NSK)

Time : 1st – 8th January 2016: 10.00 AM to 12.00 Noon
9th – 18th January 2016: 10.00 AM to 6.00 PM

Target audience: 1) Applicants currently residing outside Assam
2) Applicants residing in Assam who have missed visit of Verification Team to their house/locality



WHAT IS THE NSK BASED VERIFICATION DRIVE ALL ABOUT?

NRC Applicants residing outside Assam may plan their calendar visit to Assam during this period for self verification at their designated NRC Seva Kendras (NSKs).

- ❖ If you have applied online you may not know your designated NSK to make a visit. In that case you may locate the same by visiting the “KNOW YOUR NSK” section in NRC Assam’s official website (www.nrcassam.nic.in). Usually your designated NSK is located within your present address. If your present address is of outside Assam, your designated NSK would be located in your permanent address. Online applicants residing in Assam may search for their designated NSK in the same manner.
- ❖ **Applicants are also required to carry the following for verification :**
 1. Acknowledgement Receipt
 2. Documents submitted with Application Form. Preferably original, if not available then legible photocopy
 3. Any additional document applicants wish to submit
 4. Filled up Family Tree Form:
 - In order to identify any false claim of linkage made by unscrupulous persons to gain an entry into NRC, submission of Family Tree details by the applicants is crucial to the success of verification process.
 - Therefore, during your NSK visit, the Verification Team will ask for your family tree details in a format designed by the NRC authorities and that format is called the Family Tree Form.
 - Online applicants currently residing outside Assam can also download the PDF of Family Tree Form from the website of NRC Assam (www.nrcassam.nic.in).
 - To know more on how to fill up the Family Tree Form and its importance visit our website.
 - This format can’t be submitted online and would only be submitted at NSK.
 - Applicants can also collect blank Family Tree Form from their designated NSK during their visit and fill it up and submit on the same day.
 - However, it is advisable that applicants fill up the Family Tree Form beforehand to save time during NSK visit.
- ❖ In case it isn’t possible for all members of the household to visit the NSK, the Head of the Family or any adult member can visit and bring along the photo identity proof of the other members to get verified.
- ❖ It is not mandatory for persons staying outside Assam to visit NSK for verification. If the Verification Teams are satisfied, verification can also be conducted without requiring personal presence of applicants. However, if Verification Team find it difficult to ascertain eligibility without physical presence then the applicants would be called in.
- ❖ **Those applicants currently residing in Assam but have missed the Verification Teams visit to their house or locality may also avail this final opportunity to get themselves verified at designated NSKs.**
