Sub. – Action taken report against Media Report on lack of adequate basic facilities for NRC Applicants in NSKs.

Ref.- Letter No. SPMU/NRC/Media Report and Responses/158/2015/18 dtd. 10/07/2015.

Sir,

With reference to the subject cited above, I have the honour to submit before you the Action Taken Report against Media Report on lack of basic facilities at the NSKS:

- 1. The NSKs were selected after careful consideration of availability of minimum basic facilities and infrastructures.
- In respect of unhygienic condition, we have carefully verified the NSKs and accordingly the
  arrangement of drinking water for public, has been done through the PHE Deptt. and
  arrangement of urinals have also been arranged through GP/Zilla Parishad and DRDA of
  this District.
- 3. All LRCRs have also been instructed to take necessary steps for providing separate facilities for women and Senior Citizens.
- 4. Waiting sheds have been constructed in the premises of every NSK and one ceiling fan has been provided in every NSK in addition to the existing fans.
- 5. WIPRO has also been requested to depute additional Computer Operators at the NSKs where required with the necessary hardware.
- 6. The techniques like issue of token to the public has also been adopted to avoid crowding of public. The LRCRs have also been instructed to work beyond the office time and holidays as and when required and this is being done wherever required.
- 7. In view of the problem in filling up the Application Forms, the school/college teachers/Govt. Servants and members of social organization like Clubs etc. have also been trained arranging CLM for filling up of Application Forms.
- 8. Organizations like AASU, AAMSU and political parties have taken special initiatives and have got a large number of volunteers trained to assist public in filling up of the application forms. All possible steps for successful receipt of Forms for NRC Updation have been taken from the end of District Administration, Darrang.
- 9. In connection with the news published in "Amar Asom" dtd. 10-07-2015, all the CRCRs and CPSs are instructed to keep close vigilance on the matter of corrupt practices of middle men involved and to identify these persons and to take action against them. In one such allegation reported in village Khokhjani of Dalgaon Revenue Circle, Darrang, FIR was lodged by the Circle Officer, Dalgaon against the village Gaonburha.
