


Madam,

With reference to the subject cited above, I have the honour to furnish herewith the action taken report against Media Report published in "Dainik Janambhumi" Dtd. 18/07/2015, as I have been visiting the NSKs regularly and no such instances of claiming the eligibility against a single Legacy Data have been made so far. And also to prevent such occurrence all NSKs operators were instructed at the beginning phase of the NRC work that while giving Legacy data slip one should adhere to the rules and regulation laid down by Supreme Authority. Moreover every single care has been taken so that no such incidence of claiming the eligibility against a single Legacy Data takes place.

Again, in regards to Media Report published in Assam Tribune/The Sentinel/The Telegraph/Asomiya Pratidin/Asomiya Khabor/Amar Asom etc. Dtd. 31/07/2015 regarding issue of fake Birth Certificate, one complaint was received by Dr. Arati Hazarika, SDM & HO, Kathiatoli and accordingly she filed one FIR at kathiatoli PP for investigation and taking necessary action as per law. And also few public awareness campaigns and announcements have been made to sensitize the public about the consequences of producing birth certificates if found to be fake during verification.



Fajar Ali, L.O. and 4 others and Sri Deep Jyoti Kakati, DEE and another of Lalipathar (East Part) NSK, on 25<sup>th</sup> and 27<sup>th</sup> July 2015 respectively regarding entering of a gun man and a sword man at the Lalipathar G.P office East and West part NSKs under Dhing Circle and threatened LRCR officers, Local Officers and Data Entry Executives at their duty time for NRC updation process by Md. Habibur Rahman and Md. Joynal Uddin of that place (address unknown).

The complaint petitions have been forwarded to the O/C, Dhing Police Station for taking necessary action as per Law. The matter have already been intimated to Deputy Commissioner cum DRCR (NRC), Nagaon vide this Circle's Letter No. DCO/NRC/6/2015/70 dated 27/07/2015.


