The process of Hearing of Claims is going on across the State

- ◀ Disposal of Claims and Objections will be carried out through hearings
- ◀ Date, time and venue of the hearings will be intimated through a Notice that will be delivered house to house by NRC field level functionaries
- ◀ Persons required to appear are requested to bring for the hearing originals of all documents submitted, Notices/ Letters for Re-verification (LFR)/ Letters of Information (LOI), if any, copies of other information submitted, i.e. NRC Application Form, Claim Form, Manual Family Tree (MFT) or any other NRC related documents and valid photo identity proof
- ◀ Minors need not come for the hearing. They can be represented by their parents
