- Persons required to appear are requested to bring for the hearing originals of all documents submitted, Notices/ Letters for Re-verification (LFR)/ Letters of Information (LOI), if any, copies of other information submitted, i.e. NRC Application Form, Claim Form, Manual Family Tree (MFT) or any other NRC related documents and valid photo identity proof
- Minors need not come for the hearing. They can be represented by their parents
