## OUR NRC FAIR NRC



1. A Claim can be submitted for re-consideration of eligibility based on documents already submitted or it can be submitted with additional **List A** or **List B** documents. There is no need to re-submit the documents submitted earlier.
2. It may be noted that submission of fresh documents are not essential for filing of a Claim. Genuine Indian citizens may file their Claims in the prescribed form accordingly.
3. The list of legacy documents (**List-A**) shall remain the same as it existed at the time of the original applications. The list is as follows:
  - I. NRC, 1951
  - II. Electoral Roll up to **24<sup>th</sup> March, 1971 (midnight)**
  - III. Land documents like Registered Sale Deed, Records of land rights up to **24<sup>th</sup> March, 1971 (midnight)**
  - IV. Citizenship Certificate up to **24<sup>th</sup> March, 1971 (midnight)**
  - V. Permanent Residential Certificate issued from outside the State up to **24<sup>th</sup> March, 1971 (midnight)**
  - VI. \*Refugee Registration Certificate up to **24<sup>th</sup> March, 1971 (midnight)**
  - VII. Passport issued by the Government of India up to **24<sup>th</sup> March, 1971 (midnight)**
  - VIII. Life Insurance Corporation of India Insurance Policy (LICI) of relevant period i.e. up to **24<sup>th</sup> March, 1971 (midnight)**
  - IX. \*\*Any license/certificate issued by any Government authority of relevant period i.e. up to **24<sup>th</sup> March, 1971 (midnight)**
  - X. \*\*\*Document showing service/employment under Government/Public Sector undertaking up to **24<sup>th</sup> March, 1971 (midnight)**
  - XI. Bank/Post Office Accounts of relevant period i.e. up to **24<sup>th</sup> March, 1971 (midnight)**
  - XII. Birth Certificates issued by the competent authority up to **24<sup>th</sup> March, 1971 (midnight)**
  - XIII. Educational certificate issued by Board/Universities up to **24<sup>th</sup> March, 1971 (midnight)**
  - XIV. Records/processes pertaining to court up to **24<sup>th</sup> March, 1971 (midnight)** provided they are part of a proceeding in a Judicial or Revenue Court
  - XV. \*\*\*\*Ration Card up to **24<sup>th</sup> March, 1971 (midnight)**
- \* *Refugee Registration Certificate also includes the following variants:*
  - (i) *Relief Eligibility Certificate up to **24<sup>th</sup> March, 1971 (midnight)***
  - (ii) *Camp Inmate Certificate up to **24<sup>th</sup> March, 1971 (midnight)***
- \*\* *Includes Government receipts, notices, orders or records up to **24<sup>th</sup> March, 1971 (midnight)***
- \*\*\* *Includes Pension Payment Order (PPO) showing employment/service in Government up to **24<sup>th</sup> March, 1971 (midnight)***
- \*\*\*\* *This is only a supporting document and will be accepted only if accompanied by any one of the other fourteen (14) **List A** documents (I to XIV)*
4. In case of **List B** documents, any legally admissible document issued up to **31<sup>st</sup> August 2015**, and which is part of official records can be submitted to prove linkage
5. No change in Legacy Person will be allowed at the stage of filing of Claims
6. No change will be permitted in the Manual Family Tree Statement declared earlier by the applicant
7. Any person can make an objection in respect of inclusion of any name in the **Draft NRC**. There is no penalty for rejection of any objection
8. Claims can also be submitted by a person who:
  - a) Claims to be wrongly identified as D Voter (DV) or Declared Foreigner (DF) or a person with case pending in Foreigners Tribunal (PFT), or their descendants
  - b) Has order from Judicial Authority/Foreigners Tribunal declaring him/her as Indian but the person has not been included in Draft NRC
9. Any person who has already submitted a Claim or Objection Form before the issue of the Standard Operating Procedure (SOP) as per order of the Hon'ble Supreme Court dated 1<sup>st</sup> November 2018, and now intends to submit additional document(s) in support of the Claim/ Objection, will be allowed to submit the same at the designated NSK.
