With reference to the subject cited above, this is to inform you that an enquiry has been conducted by Circle Officer, Chenga Revenue Circle on the news clipping published in "Doinik Janambhumi" / " Asomia Pratidin" of 2nd December, 2015 into the disturbing incident of physical assault on Sri Paran Saikia. LRCR of Chenga-9 NSK at Marichakandi village under Chenga Revenue Circle. The copy of enquiry report is enclosed herewith as sought for.

In this regard, Superintendent of Police Barpeta was asked to arrange adequate security measures to the members of verification teams during field verification by sending police teams to accompany as escort for such VTs and also to alert local VDPs vide this office letter no. BANRC-33/DPMU/VP/2015/348-349 dtd. 02-12-2015. He was also requested to give special attention to very sensitive NSKs and to take exapletary action against the culprit so that no hamper may in the process of NRC Updation ie done by disruptive incidents. Moreover, a meeting with district police was also held on 03/12/2015 to discuss the security aspects of verification teams, minutes of which is enclosed herewith as ready reference.

Now, Superintendent of Police Barpeta has submitted a security arrangement plan for entire district vide his letter no. BPTA/CB/15/759-A dtd. 04-12-2015 which is circulated amongst all Circle Officers for needful action.

District administration has further decided to sensitise all VT members to prepare a village wise tour plan for verification process and inform local police well ahead of their visit to a particular area.

With reference to the subject cited above. I have the honour to furnish herewith the compliance report in respect of security arrangements for NRC verification team(s). The report is as follows:-

All the Officers-in-Charge of Police Stations and In-Charges of Out Posts of Barpeta District including the GOs were sensitized about house to house verification process of NRC applications vide this office S/No.BPTA/CB/15/558 Dated 01.09.2015 with reference to the S/No. SB.II(A)/340-NRC-2015/380 Dated 30.08.2015 of the ADGP(SB) Assam Guwahati. As per the message received from the ADGP(SB) Assam, Guwahati as referred, all Os/C and I/Cs of Police Stations and Out Posts were instructed to identify the vulnerable areas where problems may crop up and to make necessary arrangements for quick response in the event of any relevant information or requisition by verification teams.(Copy enclosed). All Os/C and I/Cs of Police Stations and Out Posts of Barpeta District were sensitized about security needs of the verification reams as per kind instruction received from the State Coordinator, NRC Assam vide information copy of his letter No. SPMU/NRC/Dist. Co. Equip (68/2015/Pt/144-A Dated 4th oct/2015

Moreover, a law and order plan/security arrangement was prepared in connection with verification of NRC applications in Barpeta District and circulated to all Os.C and I/Cs of Police Stations and Out Posts including GOs with intimation to your good office vide this office Memo No.BPTA/D-5/15/1162 Dated 07.09.2015. (Copy enclosed). As per the plan all Os/C of Police Stations were made Sector Officers in their respective jurisdiction and the I/Cs of Out Posts were made Sub-Sector Officers and they will be responsible for deployment of proper and adequate police personnel wherever it is necessary and for execution of timely and effective duties particularly to achieve the objects mentioned in the plan Supervision of senior officers has also ween outlined in the plan Moreover a meeting with all OCs was also convened vide this office memo BPTA/CB/15/559 on 03.09.2015 with all OCs of Barpeta district to sensitize about security assistance and according due seriousness to house to house verification of NRC applications. Sensitizing local VDF members riverine areas intelligence and responding to threats urcently were points of discussion. Sho S.P. Salkia, A.P.S. Addl. Superintendent of Police (Hgr) Barpeta has also been entrusted to interact with the teams engaged in NRC updating process of Barpeta.

A physical/on-spot enquiry has been ordered by undersigned whereby Shri SR Saikia APS, ASP (HQ) Barpeta probed into the incident of alleged physical assault on Shr Poran Saikia, JE, Chenga Dev. Block Cum LRCR. of NSK No. Chenga- 9 (Bahari Reserve GP office) at Marichakandi Village on 01.12.2015 by one Md. Jamalur Rahman S/O Abdul Mazid of Village-Marichakandi at the time of conducting field verification. The enquiry report will be submitted shortly. Meanwhile the undersigned has forwarded the written complaint received from Shri Poran Saikia and it has been turned into an FIR and a case has been registered vide Kasumara PS case 132/2015 u/s 353/323 IPC and all out efforts are being launched and highest priority accorded to apprehend the FIR named accused who has been absconding. On 02.12.2015 also all OsC/ICs and GOs were re-alerted through a WT message regarding strict action in NRC verification matters and OC Kasumara PS has been specifically directed in the light of the one-off incident on 01.12.2015 so that utmost priority is accorded to the legal follow-up action in the matter.
