With reference to the subject cited above, I have the honour to furnish the Action Taken Report on news clipping published in some daily News Paper about fake birth certificate as follows :-

- 1) The news items related to fake birth certificate published in some daily news papers has been conveyed to S.P,Bongaigaon with a request to take appropriate steps to apprehend the culprits/racket who are involving in issuing fake birth certificate.
- 2) The Joint Director of Health Service, Bongaigaon District has been requested to issue necessary instructions to all the Primary Health Centre under his jurisdiction to be very cautious in issuing birth certificate. He has also been requested to convey the news clipping published in some daily news paper on fake birth certificate to concern Primary Health units which are responsible for issuing such birth certificate. Involving in such illegal activities is punishable under law.
- 3) The matter related to fake birth certificate has been brought to the notice of the S.D.O © North Salmara, Abhayapuri and Bijni for taking preventive measure on news item regarding to fake birth certificate.
- 4) All LRRC of Bongaigaon District have been directed to meticulously verify the genuineness of birth certificate submitted with NRC Application form by the applicants in connection with NRC updation. Any birth certificate is found doubtful should be authenticated by the issuing authority at the time of verification.
